New Street Light Process

In order for a new location to be considered for a street light a request needs to be submitted to the committee with justification for that location. Once the committee approves the request, that location is added to the list of priority lights. The following light locations are on the priority list: Petty Jay Road (2 are needed), Thornwood Court, Cloudcroft (near the end of the street), Fallshere and Summerfield Drive, Spring Breeze Circle, and Autumn Leaf Court, not necessarily in that order. Most of these locations will be expensive due to getting to the utility boxes. Installation costs vary depending on the utility box's location. Costs range from as little as \$200 to as much as \$2,200. If there is a location that has been overlooked, please compare that location with those



already on the priority list. If you think a street light location needs to be added to the list, send us a request for consideration. At this time, FSNA pays for 38 streetlights, however, due to the lack of available funds we may not be able to afford any new streetlights.

Treating Roads With Salt in the Winter

As a trial, FSNA attempted to salt Summerfield Drive from Petty Jay Road to the top of Summerfield Drive's hill in Four Seasons II when icy conditions were predicted. A resident agreed to spread the salt if FSNA paid for the salt. That project cost \$800. Some residents sent some extra funds to help offset that project but those extra funds only covered about half of the cost. Thank you to those who helped. Our hope was to continue to treat that section along with some other streets that are difficult to transit during inclement weather. Unless dues participation improves, we may have to abandon the project due to lack of funding.
