Parking

- Metro Louisville has several regulations on parking vehicles. In a nutshell:
 - A vehicle cannot be parked in the same spot on the street for more than 24 hours
 - It is unlawful to park a vehicle on an unpaved surface such as a front yard
 - A vehicle cannot be in a state of major disassembly, disrepair, etc
 - Parking of heavy trucks is prohibited

Property Owners Yard Maintenance

- Metro Louisville has regulations on yard responsibilities. Generally speaking, yards are to be:
 - Kept clean and free from safety, health, or fire hazards
 - Weed and plant overgrowth cannot exceed 10 inches
 - Grass should be kept cut and bushes trimmed
 - Trees should be trimmed and kept away from houses and power lines
